## Marcus Engel, M.S., CPXP, CSP, Healthcare Speaker, Author & Consultant

Marcus is a certified Speaking Professional & author whose messages provide insight and strategies for excellent patient care. His keynote presentation, "The Other End of the Stethoscope" has been witnessed by tens of thousands of healthcare professionals, and his books are used in scores of nursing and allied health programs to teach the basic foundations of caregiving. As a college freshman, Marcus Engel was blinded and nearly killed after being struck by a drunk driver. Through two years of rehab, over 350 hours of reconstructive facial surgery, and adaptation through a multitude of life changes, Marcus witnessed the good, the bad, and the profound in patient care. Marcus has authored four books. He holds a B.S. in sociology from Missouri State University and an M.S. in Narrative Medicine from Columbia University in the city of New York. In 2017, Marcus was awarded an honorary doctorate from the Philadelphia College of Osteopathic Medicine and is currently an adjunct professor at the University of Notre Dame where he teaches pre-meds the art of "being with." Marcus lives in Orlando, Florida with his wife, Marvelyne, and his Seeing Eye dog, James. He loves to connect with healthcare professionals nationwide.

### Dennis Wagner, Principal and Managing Director, Yes, And Leadership, LLC

Dennis Wagner believes in committing to and delivering on Bold Aims in work and life. He is a nationally and internationally recognized leader in the areas of public service, social marketing, healthcare quality improvement, and large-scale change management. ### Kate Elliot, Vice President of Systemwide Quality Improvement, Comagine Health

Kate Elliott is vice president of systemwide quality improvement (SQI) for Comagine Health. She leads the SQI department, a broad portfolio of health care transformation and quality improvement projects for clients including federal and state governments and private institutions. SQI is composed of quality improvement experts, conveners, project managers, educators, coaches and consultants who apply their skills to improve the care delivered in a variety of settings across our communities. Ms. Elliott is passionate about using facilitative leadership approaches to support these professionals in building and sustaining high-impact programs.

Before becoming vice president of SQI, Ms. Elliott served as Comagine Health's associate executive director, leading strategic planning, business development and community engagement, providing executive leadership for the Oregon Community Board, and co-facilitating a 15-organization workgroup focused on implementation of value-based payment models in primary care. As senior director and program manager, she led the Patient-Centered Primary Care Institute, an initiative to connect Oregon primary care practices with technical assistance on emerging topics like patient-centered care, medical home and integrated behavioral health.

### Bre Holt, MPH, Senior Director of the Population Health Service line, Comagine Health

Bre Holt is senior director of the population health service line at Comagine Health. Bre is a demonstrated team leader with deep experience managing professionals to design and implement health care transformation initiatives. Previously serving as president of the University of Tulsa and the University of Oklahoma, Dr. Clancy raised over \$510 million for scholarships, research institutes, and facility expansions. He has contributed significantly to college access, ranking #1 among U.S. college presidents (2000–2023) for improving access for underrepresented minorities.

A dedicated psychiatrist, he provides emergency psychiatric services at the University of Iowa Hospital and hosts the ROUNDING@IOWA CME podcast. He also leads strategic workforce well-being initiatives at UI Health Care and advises Iowa health systems on recruitment and retention. Recognized with numerous teaching and humanitarian awards, he has also founded two medical colleges and pioneered community health programs, including outreach clinics for the underserved. His research and leadership have shaped health policy, mental health care, and medical education nationwide.
